March Board

A number of items were acted on at this board meeting. Research into sound suppressing panels for the Twigs "windows" separating our meeting from the bar was approved, and a request for a donation to The Weekly was presented by Lion Larry Sparkes for \$20 which was also approved.

It was also announced that anyone attending District Convention will be reimbursed \$25 of their expenses. There appeared to be 5 going. Business session on Saturday at 10am, Awards Luncheon following and Saturday evening banquet with our own President emceeing the event.

It was stated that we will be voting on our Festival King & Queen at our next meeting so bring your nominations, and it has been requested by Lions Mike Putnam that we go to Twigs to sell raffle tickets all day on St. Patrick's Day. The board also approved 2 new memberships.

It was brought up about our website being somewhat stagnant and that a lot of information needed to be updated. Lion Holli Idle will contact our webmaster, Lion Dave Purcel, about helping him with it and the possibility of obtaining new a new hosting company so others have access as well for updating.

\$200 was approved for signage for our chicken dinners at the Festival.

Finally it was announced that 1st Vice President Deanna Schuman will not be able to stand for President due to work conflicts so 2nd Vice President Cindy Arthur agreed to step up 2 positions and run for the position, and she presented her slate of officers for the new year.

February Board

At the February Board meeting, in addition to the approval of the minutes and Treasurer's report, the upcoming spaghetti dinner was discussed and all is set for it. It was also mentioned that we served 141 meals at the last one.

The Board approved a \$1,000 donation to the Robotics Team at the high school, and also announced that our recent Texas Hold Em poker event brought in \$2,679 profit.

There was also a change to the By-Laws which all members will receive via email. A change to No. 13 and a new No. 15 were approved at the regular meeting prior to the board.

The Board also approved \$200 for the purchase of signage to be used at the spaghetti dinner on A-frame sidewalk boards that were donated, and they approved a \$250 donation to Respite of Shiawassee County.

Finally, there was a discussion concerning members not participating in our projects (both service and fundraising) and what can be done to get others to participate.
